☐ Teacher Evaluation Forms (2): Delegate one form to a current teacher, and the second can be a
past teacher. Both teachers should teach core subjects if possible. Forms are delegated
through Ravenna directly to the teachers' email addresses.

SIBLING VISIT INFORMATION

Early Student Visits begin on Oct 16 and continue through Dec 8 for the earlier deadline. Visits are a half-day, scheduled from 8:30 AM to 12:00 PM or 12:45 PM to 3:30 PM. Applicants are matched with a current student and visit classes.

Please note: The visit is a required part of the application process. Therefore, the student visit must be completed by Dec 5 for your application to be considered complete and on time for the early decision.
